## 'Boat on Trailer' or 'Boat Trailer' Storage Terms and Conditions



1. Access to the boat/trailer storage area (as indicated above) is controlled by Weymouth Harbour between the hours of 08:00 – 17:00 to deposit/collect boats on trailers and not for any other purpose. Commercial area contact number 01305 838427.
2. There is no car parking available for this site and cars must not park within the boat/trailer storage area.
3. This facility is provided for boat on trailer or boat trailer storage only and not for the purpose of a maintenance area to work on the boats, as such no additional facilities such as water and electric are available/to be used.
4. You warrant that all equipment requested for storage with Weymouth Harbour is in full working order and in trailerable condition.
5. You warrant that there are no hazardous materials stowed in the vessel.
6. If a sailing vessel, all sails must be removed and be securely stowed.
7. For security reasons, customers are not permitted to visit the storage area unless accompanied by a representative from Weymouth Harbour.
8. All fees for storage are payable in advance unless otherwise specified and are non-refundable.
9. All items and equipment will be stored at owners' and users' risk and without any liability for Weymouth Harbour.
10. Weymouth Harbour requires the owner to provide the appropriate insurance cover and you hereby warrant that your boat (and all other equipment left for storage with Weymouth Harbour) is fully insured against fire, theft and accidental damage and includes 3rd party cover up to two million pounds. You are also required to provide any security devices you wish to use.
11. Weymouth Harbour staff may need to move the trailer if required.
12. Any abandoned equipment will be put up for sale 1 month after contact with the owner is lost.
13. Storage is subject to availability.
14. Weymouth Harbour will give at least 4 weeks' notice for termination of the storage facility.
