

# TEMPORARY CLOSURE OF VARIOUS ROADS, WEYMOUTH FOR WEYMOUTH CARNIVAL PROCESSION

# TEMPORARY PROHIBITION OF THROUGH ROAD WAITING OR LOADING AND UNLOADING

For the purpose of a carnival procession, DORSET COUNTY COUNCIL has issued a Notice under Section 16A of the Road Traffic Regulation Act 1984 to prohibit the use of the various roads described below, at the times shown, by cyclists, horse riders and all mechanically propelled vehicles, except those taking part in the event and emergency vehicles -

## On Wednesday 15 August 2018.

(All restrictions are on Wednesday 15 August unless otherwise described)

#### Road closures

- **The Esplanade** between King Street and Custom House Quay in both directions (16.30hrs 20.30hrs\*)
- The Esplanade between Custom House Quay and Pavilion Car Park in both directions (17.15hrs 20.30hrs\*)

The following roads will be closed between 17.15hrs and 20.30hrs\*, in both directions:

- Preston Beach Road between Overcombe Corner and Greenhill
- Greenhill
- The Esplanade between Greenhill and Custom House Quay
- Dorchester Road between Greenhill and Carlton Road South
- Westerhall gyratory
- Melcombe Avenue
- William Street
- Lennox Steet between Greenhill and Victoria Street
- Astrid Way

As a result, there will be no access to The Esplanade from Gloucester Street, Westham Road, New Street, Bond Street, East Street or St. Alban Street.

(i) **The Esplanade** will be reopened to vehicular traffic as the Procession passes by key points along the route.

(ii) Alternative routes for traffic will be signed.

(iii) \*reopening times of 20.30 are indicative and roads will reopen as soon as it is deemed safe to do so.

# <u>As a result of the closures listed above, the following measures will take effect, between 17.15hrs and 20.30hrs (approx.):</u>

- Custom House Quay the one-way system will be suspended
- Gloucester Mews the one-way system will be suspended
- East Street between Mitchell Street and Market Street the one-way system will be suspended
- St. Thomas Street a temporary taxi rank will be introduced at Coburg Place

#### Parking restrictions

The following parking places will not be available between 02.00hrs and 20.30hrs (approx.):

- the **west side of The Esplanade** (i) between the Royal Hotel and Gloucester Street (ii) between St Mary Street and East Street
- the seaward side of Alexandra Gardens
- the east side of The Esplanade, between (opposite) New Street and (opposite) East Street

Parking places will remain open at the **Pier Bandstand and along Brunswick Terrace**, however access will be limited when road closures are in force.

### Permit holders

Holders of permits for **zones A, C, F and H** can park in the following off-street car parks free of charge, subject to availability of spaces and between the times shown:


- **Pavilion Car Park\* and Swannery Car Park** between 18.00hrs Tuesday 14 August 2018 and 08.00hrs Thursday 16 August 2018.
- Melcombe Regis Car Park and Park Street Car Park between 18.00hrs Wednesday 15 August 2018 and 08.00hrs Thursday 16 August 2018

# <u>Any vehicle waiting in contravention of any restriction imposed by this order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986.</u>
