

**Weymouth Town Slipway Annual Permit Application Form**

**I confirm and acknowledge that:**

1. I hold valid 3<sup>rd</sup> party insurance (£2m minimum).
2. I will not permit any person under the age of 12yrs (16yrs for PWC) to use/launch my craft unless that person is under my personal supervision.
3. I understand the areas of water that I can and cannot enter with my craft and that current regulations are understood and will be complied with.
4. I will carry my permit card when using the Slipway.
5. I take full responsibility for my own actions and that of any named and/or permitted drivers and absolve Weymouth Harbour Authority from any liability for damage sustained to me, my property and/or users of my craft, damage to a third party or their property whilst accessing the Slipway, launching, using my craft, recovering or exiting the site.

**I understand that failure to comply with the above directions will result in further action and could result in withdrawal of my permit to launch from Weymouth Town Slipway and managed sites.**

**This permit is issued subject to compliance by the holder with the regulations of Weymouth Harbour Authority and the reasonable requests of their authorised staff to whom this permit must be produced upon request. Regular permit checks will be undertaken. This permit is not transferable to any other person or craft and the permit holder is responsible for its renewal.**

**NOTE:**

1. Inappropriate behaviour whilst afloat may result in the Permit being revoked.
2. An additional Personal Water Craft (PWC) Permit is required for any powered aquaplaning activity in Weymouth Bay, including personal watercraft (jet-skiing), water skiing, wakeboarding and the towing of donuts, etc. This permit can be obtained from the town slipway hut when open or alternatively at the Harbour Office.
3. Parking of a trailer will incur an additional cost and should be paid for each time parking is required. Payment can be taken for trailer parking at the town slipway hut when open or alternatively at the Harbour Office.
