

### **Application for Discounted Annual Season Ticket for Annual Berth Holders**

As an annual berth holder on Westwey or North Quay pontoons you are entitled to a discount if you wish to purchase either Season Ticket A or B (see listed car parks overleaf). The discount is 50% of the price Season Ticket B, currently £162.50.

The permit can be used for up to three different vehicles and you will need to provide all Vehicle Registration Plates for us to complete the application. The permit will run from the 1<sup>st</sup> day of the month that you apply, for a full calendar year (i.e. if you apply on the 15 June, it will be valid from 1 June – 31 May).

If you relinquish your berth before the end of the year, a pro-rata refund against the discounted sum will be recovered.

## Parking Permit Conditions of Use:

1. When a vehicle is parked on any day the original permit issued by the Council (no photocopies) must be displayed so that all of the details on its front side (permit number, expiry date etc) are clearly visible through the front windscreen of the vehicle.
2. The vehicle must be parked wholly within a parking bay.
3. The permit remains the property of the Council and it can be withdrawn for misuse.
4. The issue of a permit does not guarantee the holder a parking space, nor does it render the Council subject to any liability in respect of loss or damage to any vehicle or its contents or fittings.
5. The responsibility for applying for the renewal of a permit rests with the holder.
6. Should a permit be lost or the vehicle changed please phone 01305 838236 and quote the permit number. There is a charge for replacement of a lost permit but no charge for a change of registration.
7. A vehicle is likely to be issued with a Penalty Charge Notice if the permit is expired, not displayed correctly or not for the relevant vehicle or car park.
8. A Penalty Charge Notice may be issued to any vehicle parked in contravention of the requirements of the current Weymouth & Portland (Off-Street) Parking Places Order.
